5. Parking or driving on fields or courts is not permitted.
6. The consumption of alcoholic beverages on public property is against the law. Please understand that the permitting organization will be responsible for the behavior of all participants and spectators at their approved field permit times.
7. Arlington Recreation reserves the right to change schedules or revoke permits without prior notice.
8. No open fires are permitted at any time.
9. Fields or courts used by school teams will not generally be available before 5:30 PM. In any case, school teams must be allowed to finish their activities before your group may take the field or court, regardless of the starting time on the permit.
